Most Precious Blood is a growing, lively and thriving community. Under Fr. Pat's leadership, the number of registered families has increased 2 ½ times, yet our facilities have not changed in decades. While construction is underway on several necessary and exciting projects to accommodate this growth, we are still actively fundraising for our *Here for Good* campaign. We need to raise an **additional \$2,300,000** to meet our **total goal of \$9,700,000** to fund the following:

- Opening in January 2019, the NEW **Parish Office** (formerly the Parish Center) encompasses nearly **10,000** square feet of newly renovated space, featuring 15 offices, 3 conference rooms, ample storage and a welcoming reception area. The new space will be accessible to **all** parishioners and guests, including those with disabilities who cannot currently enter our offices.
- Set to open in December 2019, our NEW **Parish Center** comprises over **11,000** square feet of new construction, including a large hall for 250 guests seated at round tables, a catering kitchen, four meeting rooms and a seminar room.
- Critical deferred maintenance projects will be completed, including a new roof for the church and part of the school, re-stucco the church steeple, remodeled church restrooms, new fire suppression system and new paint for the interior of the church and replacement of the school sewer line. Site improvements such as a new school playground and new facility maintenance building will also be accomplished.

**Here are the easy ways to contribute:**

Check

- Mailed – The envelope containing a personal check or a check through your bank's bill pay system **must be postmarked** no later than December 31, 2018.
- Offertory basket, dropped by the office or in the mail slot – Deadline of December 31, 2018.

Online through Faith Direct

- **Regular** scheduled credit card/checking/saving payments will happen as usual on December 4<sup>th</sup> & 15<sup>th</sup>.
- **One-time** year-end contributions
  - To contribute through your **checking/savings account**, contact the Faith Direct support team at 866-507-8757 no later than December 20<sup>th</sup> to assure your **one-time** contribution will be credited to your 2018 giving. Please note if it is for a regular church contribution or for the *Here for Good Campaign*.
  - Contribution via **credit card** may be made by going onto the Faith Direct site by December 31<sup>st</sup> at 11:30 PM to assure your **one-time** (in real time) contribution will be credited to your 2018 giving. You will need to have an account, and it is critical that you note if your contribution is for a regular church contribution, for the *Here for Good Campaign* or other.

## Stock donation

- To assure your contribution through a stock trade gets credited to your 2018 giving, we strongly suggest that you have that transaction complete by December 21<sup>nd</sup> and follow these steps:
  1. ***Please contact Mary Knowles, MPB's Business Administrator, with the name of the stock that you are selling and where you would like to direct your gift.*** This can be done via email, [mknowles@mpbdenver.org](mailto:mknowles@mpbdenver.org) or phone 303-756-8083. We **do not** receive any notification from Coughlin as to who donated the stock. By informing us of your donation, we can acknowledge your gift and track it for tax purposes.
  2. Submit the following information to your broker:
